### SIGNERS

- ⇒ Must be registered to vote.
- ⇒ Must be 18 years of age by November 5, 2024.
- ⇒ Must sign in blue or black ink.
- ⇒ Must fill out and sign the petition themselves.

### VOTERS

### CIRCULATORS:

- ⇒ Must staple the 15 page petition on the top margin.
- ⇒ Must be at least 18 years of age.
- ⇒ Must write in the appropriate county on each signing page.
- ⇒ Must keep petitions separate by county. OC signers on OC petitions. LA with LA, etc.
- ⇒ Must show each signer the Official Top Funders information on page 2.
- ⇒ Must insure that the Official Top Funders information is current. Circulate January petitions in January. February in February.
- ⇒ Complete and sign the Declaration of the Circulator. Page 15.
- ⇒ Must return completed petitions to the address below.
